Hon. Mark Eyking (Sydney—Victoria, Lib.): Wayne Easter is on his way in.

Mr. Pierre Lemieux: All right. I'll move quickly.

Voices: Oh. oh!

Hon. Mark Eyking: You'd better be quick.

The Clerk: Is it the pleasure of the committee to adopt the motion?

Some hon. members: Agreed.

**The Clerk:** I declare the motion carried and Mr. Eyking duly elected second vice-chair of the committee.

I now invite Mr. Shipley to take the chair.

**The Clerk:** There is only one thing. It's the speaking order, because it was based on 12 members, not 10. It's up to you.
