

Julie Dzerowicz (Davenport, Lib.): I would like to nominate the wonderful and amazing Judy Sgro.

**An hon member:** I second that.

**The Clerk:** It has been moved by Ms. Dzerowicz that Ms. Sgro be elected as chair of the committee.

Are there any further motions? I see none.

(Motion agreed to)

**The Clerk:** I declare Ms. Sgro duly elected as chair of the committee.

**Some hon. members:** Hear, hear!

**The Clerk:** I invite Ms. Sgro to come to the table.

The Chair (Hon. Judy A. Sgro Humber River—Black Creek, Lib.): I committed a long time ago to short meetings and as few meetings as possible.

With the agreement of the committee, I will invite the clerk to proceed with the election of the vice-chair.

**The Clerk:** Thank you, Madam Chair.

Are there any motions?

Mr. Duguid.

Hon. Terry Duguid (Winnipeg South, Lib.): With pleasure, I'd like to nominate Mr. Kelly McCauley.

**The Clerk:** It has been moved by Mr. Duguid that Mr. McCauley be elected as vice-chair of the committee.

Are there any further motions? I see none.

(Motion agreed to)

**The Clerk:** I declare Mr. McCauley duly elected as vice-chair of the committee.

That the clerk of the committee be authorized to grant access to the committee's digital binder to the offices of the whips of each recognized party.
