First Quarter of 2018–2019 Posting of the *Members' Expenditures Report*, the *House Officers' Expenditures Report* and the *Public Registry of Designated Travellers*

The Honourable Geoff Regan, Speaker of the House of Commons and Chair of the Board of Internal Economy, announced today that the [Members' Expenditures Report](#) and the [House Officers' Expenditures Report](#) for the first quarter of 2018–2019 as well as the [Public Registry of Designated Travellers](#) as at June 30, 2018, are now available to the public on [ourcommons.ca](http://ourcommons.ca).

### Members' Expenditures Report

The Members' Expenditures Report for the first quarter of 2018–2019 outlines Members' expenditures processed between April 1 and June 30, 2018. It includes the Detailed Travel Points Report, which provides information on Members' and authorized travellers' trips for which travel points are used, as well as the Detailed Hospitality Expenditures Report, which provides information on Members' hospitality expenses.

### House Officers' Expenditures Report

The House Officers' Expenditures Report for the first quarter of 2018–2019 outlines House Officers' and National Caucus Research Offices' expenditures processed between April 1 and June 30, 2018. It includes the Detailed Travel Expenditures Report, which provides information about House Officers' and their employees' trips, as well as the Detailed Hospitality Expenditures Report, which provides information on House Officers' hospitality expenses.

## Public Registry of Designated Travellers

The Public Registry of Designated Travellers indicates the names of Members' designated travellers as at June 30, 2018.

### Quick Facts

- For the first quarter of 2018–2019, the House Officers' Expenditures Report includes expenses processed for House Officers and National Caucus Research Offices between April 1 and June 30, 2018.
- Starting in 2018–2019, the House Officers' Expenditures Report is published on a quarterly basis and includes the detailed disclosure of travel and hospitality expenses.
- Members and House Officers are responsible for ensuring that all approved expenses are incurred in the discharge of their parliamentary functions.
- Expenditures incurred by Members and House Officers are subject to the Members By-law and the Members' Allowances and Services Manual.
