### X-RAY MACHINES PROCUREMENT PROCESS BACKGROUNDER

### BPTS - 02890-2020.

The requirement for x-ray machines and associated services are ongoing requirements for Global Affairs Canada's 178 Missions. Beginning in the summer of 2019, the International Platform Branch of Global Affairs Canada resumed work on the establishment of a long-term supply instrument that would allow the Department to respond to the needs of Missions to replace x-ray machines and provide associated services, such as installation, maintenance, yearly testing, training and disposal.

It was determined that a standing offer was the most suitable supply instrument, which due to its non-binding nature, would give Global Affairs Canada the flexibility to issue contracts only when a need is identified through a call-up. Global Affairs Canada and the Government of Canada are not obliged to issue any call-ups during the lifetime of the standing offer and it has occurred before that standing offers have not been used. The Global Affairs Canada standing offer awarded to Nuctech is not a contract and no call ups have been issued. In other words, no purchases of x-ray machines have been made under this standing offer.

The International Platform Branch of Global Affairs Canada, as the technical and requisitioning authority, developed the statement of work and requirements definition, as well as the technical evaluation criteria and obtained the Departmental Contract Review Board approval for this requirement. Public Services and Procurement Canada was identified as the contracting authority as this requirement was above Global Affairs Canada's contracting delegation.

Public Services and Procurement Canada worked in collaboration with Global Affairs Canada and issued a request for standing offer on behalf of Global Affairs Canada on December 16, 2019, for an initial period of forty days in accordance with our obligations under the trade agreements. Following a number of extensions to address vendors' questions, the bid period closed in April 2020. Seven bids were received on the x-ray machines portion of the request for standing offer. The bids evaluation process was conducted in two phases. In the first phase, the International Platform Branch as the technical authority, with the support of the Mission Readiness and Security Program representing Global Affairs Canada's Chief Security Officer, evaluated the technical proposal from the vendors. In order to be further considered each vendor had to meet all mandatory requirements. Through the technical evaluation, three vendors met all mandatory requirements, including Nuctech. The results of the technical evaluation were forwarded to Public Services and Procurement Canada for the financial evaluation and contractor selection based on the lowest financial proposal that was technically compliant. Since Nuctech met all the mandatory technical requirements and had the lowest financial proposal at \$6.8M, Nuctech was awarded the standing offer for x-ray machines.

The standing offer was awarded to Nuctech on July 15, 2020. Public Services and Procurement Canada informed all non-winning bidders, including one Canadian firm, of the award of the standing offer to Nuctech. Public Services and Procurement Canada also notified unsuccessful bidders of available recourse mechanisms including the complaints processes at the Canadian International Trade Tribunal as well as the Office of the Procurement Ombudsman.

This procurement process was conducted in accordance with the Treasury Board Secretariat contracting policy as well as Public Services and Procurement Canada and Global Affairs Canada departmental contracting policies. As per Canada's obligations under trade agreements including the World Trade Agreement where both Canada and China are signatories, when a requirement meets a certain financial threshold, the public procurement process is open to qualified vendors in all signatory countries. When Global Affairs Canada initiated this procurement process, it estimated the total value of the x-ray portion to \$6.6M over five years.

The National Security Exemption was not applicable in this procurement as x-ray machines are not covered. A security requirement check list was included in the solicitation as per standard procurement required documentation to be sent to Public Services and Procurement Canada. The security requirement check list was reviewed by Public Services and Procurement Canada's Canadian Industrial Security Directorate who determined that there were no security requirements for this procurement as x-ray

machines do not store data, are not connected to the network and the machines are to be used in nonoperational zones.

Although Nuctech is a first time vendor with Global Affairs Canada, it has had previous contracts with the Canadian Border Services Agency. On the last contract awarded to Nuctech, Public Services and Procurement Canada's Canadian Industrial Security Directorate asked that if this company were to win another contract, to clear it through them first.

Should Global Affairs Canada determine that security requirements are necessary in procuring x-ray machines, the Department could decide to not use the standing offer issued on July 15, 2020 and run a new procurement process that would include security requirements.

Global Affairs Canada will conduct a review of existing supply instruments to identity any arrangements it may have with countries that may not serve Canada's best interests.

# **Nuctech X-Ray Machines at GAC missions**

# KEY ASSESSMENTS\* In several incidents of espionage against Canada, Chinese intelligence was identified as the probable perpetrator. GAC operates in many environments where the threat from, and our vulnerability to espionage is substantially greater than in Canada. Installation and maintenance of these machines at GAC missions would need to address the Department's espionage threat profile and require corresponding safeguards including, These measures could partially mitigate but would not eliminate the elevated threat from espionage. \*This assessment draws on publicly-available information.

### **BACKGROUND**

- 1. On July 15, 2020, Global Affairs Canada (GAC) awarded a National Master Standing Offer to the Chinese state-owned enterprise (SOE), Nuctech, as a means for the department's 178 missions to replace x-ray machines and provide associated services, such as installation, maintenance, yearly testing, training and disposal.
- 2. X-Ray machines are standard mitigation equipment, and are present at most GAC facilities, with some exceptions. X-Ray machines are not connected to Signet D. Some models have Wi-Fi connectivity. Most will have USB connectivity and the capability to connect to printers.
- 3. Nuctech was chosen because it was the technically compliant bidder with the lowest bid. As per Canada's obligations under trade agreements including the WTO to which both Canada and China are signatories, Chinese firms could not be excluded from the solicitation process. A National Security Exemption (NSE) was not applicable in this procurement as x-ray machines are not covered by a NSE.
- 4. The Canadian Industrial Security Directorate of Public Services and Procurement Canada (PSPC) determined that there were no security requirements for this procurement as standard x-ray machines do not store data, are not connected to the network and the machines are to be used in non-operational zones at missions (that is, in public reception areas only).
- 5. GAC and the Government of Canada are not obliged to purchase any products or services from Nuctech during the lifetime of the standing offer. There are previous cases in which a standing offer was awarded and no goods have been purchased against a standing offer, for various reasons.

### **ESPIONAGE THREATS TO GAC**

- 6. The Department uses a combination of security policies, infrastructure, and security hardware to mitigate the threat to Government of Canada personnel and information across the mission platform from espionage activities.
- 7. The threat profile of each mission is different and unique to the environment. However, there is an elevated baseline threat of espionage facing all of Canada's missions abroad. The Department is threatened by extremely sophisticated adversaries with abundant resources who are willing to take substantial risk, and who have a demonstrated willingness to target us in third countries.

8. The local contexts in which GAC operate abroad are not under the Departments' control (unlike government operations in Canada) thus rendering mitigation difficult and increasing our vulnerability to the threat. Sophisticated actors seek points of vulnerability, where lower levels of security controls may present opportunities to compromise an entire operation or network, and have the capacity to operate globally to leverage these opportunities.
9. Canada in general has a history of being targeted for espionage, including cyber attacks against Cabinet ministers and officials (e.g. the 2020 Russia-linked <i>Consortium News</i> hacks); insider attacks (e.g. 2011 Jeffrey Delisle cases); human intelligence (e.g. between 2004-2014 alone the Canada Border Services Agency (CBSA) reported the expulsion of 21 people on suspicions of espionage); economic espionage (e.g. the 2014 Chinese cyber attack against the National Research Council); and cyber attacks against line departments' IT networks
10. In several incidents Chinese intelligence was identified as the probable perpetrator, including attempted intimidation of human rights activists (2005), allegations (later retracted) of influence operations (2010), attempted recruitment of journalists (2012), theft of military information (2013), the recruitment of a Chinese immigrant for espionage (2006-10), and the National Research Council hack (2014).
11. In December 2019 CSIS stated that Chinese intelligence activity affecting against Canada is one of the largest direct threats to Canada's national interest and prosperity.
The overall threat of espionage targeting the Government of Canada – including GAC – has grown due to an increasingly volatile global environment with evolving bilateral and multilateral relationships, and particularly, from China. Additionally, developments in technologies have allowed for greater espionage gains with lower risk of exposure.
13. The range of espionage activities that GAC has experienced since 2012 covers the full spectrum of such activities,
including several forms of technical and cyber attacks (e.g. spear phishing).
14. Our adversaries may also seek to exploit the insider threat tactic, by co-opting individuals with access to the mission into introducing means to bypass technical defences.
15. The use of non-Canada based, non-Allied
contractors is a known vulnerability in this regard. While missions routinely make use of local
contractors is a known vulnerability in this regard. While missions routinely make use of local contractors and other service providers for various maintenance and provision requirements, local intelligence services are known to target these individuals for compromise through a variety of tactics (patriotism, financial reward, family or other pressure). Once recruited, compromised individuals can be tasked to undertake any manner of activities against the



mission, including technical attacks.

- 16. China is one of the most sophisticated intelligence collectors. The Chinese intelligence apparatus is large and sophisticated, and uses the full range of espionage techniques, including:
- a. Compromising individuals in key positions, such as business professionals, contractors, technicians, IT professionals, trainers, security personnel, and diplomats, both wittingly and unwittingly, willingly and unwillingly;
- b. The capacity to run highly sophisticated cyber attacks, by attacking the hardware and software of targeted systems, both critical and peripheral, to compromise systems, gain control, and steal data;
- c. The capacity to implant listening devices and other pieces of technology that compromise the operation of a machine, subvert its functions, or house other nefarious equipment which could capture communications signals and then store them for future retrieval or transmission by hostile actors.
- 17. One example of this was in 2018 when it was reported that China massively bugged the Chinese-built African Union's (AU) headquarters, and compromised the IT systems so that information stored on the AU's computers were sent to servers in Shanghai.

### X-RAY MACHINES AS A VECTOR OF ATTACK

- 19. X-ray machines present two main vectors of vulnerability: 1) supply chain compromise; and, 2) insider threat (during installation and maintenance). Supply chain attacks in particular target organizations by implanting hostile hardware or software into any technology they use during the manufacturing of the product or its components. All technology is susceptible to hacking, and provide potential vectors of attack, and any off-the-shelf technology can be compromised. High profile examples of targeted technologies have included mobile phones, routers, desktop computers, and servers.
- 20. Compromise can occur at any stage of the product's lifecycle, including the manufacturing of components, the assembly of the product, delivery, installation, software updates, and physical maintenance. Supply chain attacks have been a persistent and growing issue within

- 22. Compromised X-ray machines would provide numerous opportunities for attack:
- a. covert collection of scanning images and transmission to third party via Wifi, Bluetooth, mobile signal, or exfiltration via USB
- b. compromising of portable electronics transiting through a machine via implanted technology;
- c. spoofing of scanning results, defeating the security layer, and thus, allowing bringing nefarious devices into the Chancery;
  - d. access to a mission network via implanted technology; and
  - e. Bluetooth, mobile signal, or even electro magnetic emanation capture.

In 2014 the U.S. banned the use of Nuctech X-ray scanners at airports nationwide for just such concerns.

23. Technical attacks of this nature also magnify the insider threat, and place all parties associated with the machine, from installers, maintenance workers, IT support, and operators at risk of being targeted for compromise.

### **NUCTECH**

- 24. Nuctech Company, Ltd is a major global supplier of security inspection products, particularly X-ray technologies. It is a Chinese SOE that was created in 1997 with direct connections to the People's Liberation Army and the Chinese Communist Party. The company was once headed by the son of former General Secretary Hu Jintao.
- 25. This is the first contract between Nuctech and GAC, though Nuctech has won several contracts with the CBSA, and operates most of the X-ray machines at airports across Europe. The U.S. since 2014 has been advocating for countries to disengage with Nuctech in particular, and with Chinese companies that provide security hardware more generally.
- 26. Nuctech has been involved in several controversies, including alleged bribery cases in Africa and Taiwan, and allegations the company sold inferior products at inflated prices to Malaysia and the

Philippines. The company is also accused of selling their products at a loss as part of a long term strategy of dominating the market (so-called dumping).

27. A standing offer for X-ray machines and their maintenance at Canadian missions abroad could be leveraged for technical and insider spying against GAC. The Nuctech supplier – banned from U.S. airports contracts since 2014 - represents an elevated threat because of the company's direct relationship to, and legal obligations toward Chinese authorities.

Proposed response to four questions below. D

This is the first time that GAC has a supply instrument with this company. The intent of our lifecycle replacement initiative for detection equipment is to replace all x-ray machines currently out in the field over the next three years, at a rate of approximately 50 x-ray machines per year (for a total of 150 x-ray machines after 3 years.) The roll-out is part of GAC's cyclical replacement for the x-ray machines. The exact order of Missions to receive new x-ray machines is not yet known. The intention of this procurement was to purchase x-ray machines and walk through metal detectors for Canada's mission network. The X-ray machines, known as Group 1 of the standing offer was awarded to NucTech and the walk through metal detectors, known as Group 2 of the standing offer was awarded to Rapiscan. For Group 1, we required a conveyor style x-ray machines with monitor and operating systems, as well as warranty, maintenance, installation, training, yearly testing and disposal. The standing offer is attached for reference.

Procurement is also conducted in a manner that will stand the test of public scrutiny and reflect fairness in the spending of public funds. Furthermore, all procurement is in compliance with the procedural obligations of the World

Trade Organization Agreement on Government Procurement (WTO-AGP). These principles guide all of Global Affairs Canada's procurement processes, including the standing offer with Nuctech.

With respect to media reports, as you know, Canada believes in freedom of expression and media freedom. It is our view that a fully independent press is essential to provide citizens with accurate information and informed analysis.

I'd like to perhaps propose:

- 1. An open and competitive solicitation process was conducted in accordance with applicable procurement policies at GAC and TB, regulations, and our obligations under the trade agreements, through a RFP resulted in 3 compliant bids received. Nuctech, being the top ranked vendor following the bids evaluation, was recommended for the award of the Standing Offer by PSPC. The SO was subsequently awarded to Nuctech by PSPC.
- 2. A Standing Offer is not a contract and does not bind GAC or the government of Canada into procuring any equipment or services from the vendor i.e the standing offer can be relatively easy to set-aside.

Also, we've just got some words back from PSPC and here are some additional information from PSPC procurement:.

- 1. Steps taken to validate security by PSPC: The PSPC procurement officer mentioned that this company had also won contracts with CBSA. On the last contract awarded to Nuctech, Canadian Industrial Security Directorate (CISD) asked that if this company were to win another contract, to clear it through them. The contact at CISD determined that there are no security requirements for this procurement, and it was decided that the company was cleared. The reason there was no security requirement was that the machines do not store data, and the machines were to be used in non-operational zones. AWC also confirmed this.
- 2. PSPC Senior Management awareness: The PSPC procurement officer raised the issue to PSPC Senior management and they came to the same conclusion. They also said there was no basis to stop the procurement because Canada never stopped doing business with Chinese companies
- 3. Media enquiry response by PSPC: PSPC is currently finalizing an official response to the media enquiry stating; the lack of security requirement, the fact that this was a Public tender based on lowest cost and technically compliant as well as the fact that Canada is still doing business with China as reasons this has been awarded.

A few info I can provide about the X-Ray machines requirement at this moment.

In term of background to this X-Ray procurement. It is important to note that this is a Standing Offer (SO) and not a contract. In a SO, a contract is entered into when a call-up is placed. It is therefore possible (although counterproductive) for GAC to not to make use of the SO by not placing any call-ups.

About the procurement process, AAC have worked with AWC over the last several months on this requirement. Due to the high value of the procurement covering for both equipment and services, PSPC has the required contracting delegation and was in charge of the solicitation process on behalf of GAC.

The open and competitive solicitation process, handled in accordance with applicable procurement policies at GAC and TB, regulations, and our obligations under the trade agreements, through a RFP resulted in 3 bids compliant bids received. Nuctech, being the top ranked vendor following the bids evaluation, was recommended for the award of the Standing Offer. I was informed that PSPC had done a review on potential security risks in awarding a contract to a Chinese vendor but I am not aware that any risks were flagged. Details about the reviews done by PSPC could be validated with them as soon as we make contact.

- Roles and responsibilities related to determining security requirements OPI 1) Reid and Derrick for C Branch and

  - On security equipment procurement, C Branch should be consulted both in the RFP development process as well as before award
  - Need to review roles and responsibilities between PSPC's security directorate (CISD) and clients such as
     GAC, to make sure political and security risk assessments are not mixed with technical security assessments.

- Ensure we all have a common definition as to what constitutes "security equipment" for the purposes of this review

  - Some of the analysis is pending from partners

Background on standing offer with Nuctech

The requirement for x-ray machines and associated services such as installation, maintenance, yearly testing, training and disposal are ongoing requirements for Global Affairs Canada's (GAC) 178 Missions. Prior to the work to establish a Standing Offer for X-Ray machines and associated services, X-Ray requirements coming from the Missions were more or less handled as the need is identified with contracts awarded for a limited number of Missions at a time. These contracts had to be established once every one-two years. The last two contracts were established with Smiths Detection in 2018. The first one was for 25 X-Ray machines (15 in firm order + 10 as option) at a value of \$1.01M, and the second was for the installations of those machines at identified Missions valued at \$99K. These two contracts were aimed at providing X-Ray machines to Missions in critical need of replacements.

This situation resulted in a need for continuous procurement work on this commodity as once a contract is established, work should start right away on establishing the next one. This was neither effective (long delays in every new contract established), efficient (no consistency), nor arguably compliant (could be deemed as contract splitting with multiple contracts awarded for a same requirement). In addition, a higher volume of work is put on procurement at AAC and the technical authority at AWC with already limited existing HR capacity.

To address the three shortcomings mentioned, it was determined that there was a need to establish a stable and long-term supply arrangement that would allow GAC to address the needs of its Global Network on X-Ray equipment and associated services.

The International Platform Branch of GAC, as the technical (AWC) and requisitioning authority (AAC), developed the Statement of Work and requirements definition, as well as the technical evaluation criteria of solicitation, and obtained the Department's contract review board (DCRB) approval for this requirement. Public Works and Procurement Canada (PSPC) was identified as the contracting authority as this requirement was above the Department's contracting delegation granted by TBS

Following the requisition for procurement sent to PSPC, It was determined that a Standing Offer was identified as the most suitable solution for GAC's needs. A Standing Offer, due to its non-binding nature, would give GAC the flexibility to issue contracts only when a need is identified through a call-up. Global Affairs Canada and the Government of Canada is not obliged to issue any call-ups during the lifetime of the Standing Offer and it has occurred before that Standing Offers have not been used.

During the same period, early 2019, GAC also worked with PSPC on the establishment of a Standing Offer for Walk Through Metal Detectors (WTMD). After receiving separate requisitions for X-Ray and Walk Through Metal Detectors, PSPC suggested to issue a single solicitation covering both requirements. Two Standing Offers would be awarded, one for the WTMD (ultimately awarded to Rapiscan Systems Inc., a US company), and the other one for X-Ray. This was in the Summer of 2019.

Publication Works and Procurement Canada worked in collaboration with Global Affairs Canada and issued the Request for Standing Offers (for WTMD and X-Ray) on behalf of Global Affairs Canada on December 16, 2019, for an initial period of forty days in accordance with our obligations under the trade agreements. Following a number of extensions to address vendors' questions, the bid period closed in April 2020. Seven bids were received on the x-ray machines portion of the Request for Standing Offer. The bids evaluation process was conducted in two phases. In the first phase, the International Platform Branch (ACM) as the technical authority, with the support of Mission Readiness and Security Programs (CSI) representing Global Affairs Canada's Chief Security Officer, evaluated the technical proposal from the vendors. In order to be further considered each vendor had to meet all mandatory requirements. Through the technical evaluation, three vendors met all mandatory requirements, including Nuctech. The results of the technical evaluation were forwarded to Public Works and Procurement Canada for the financial evaluation and contractor selection based on the lowest financial proposal that was technically compliant. Since Nuctech met all the mandatory technical requirements and had the lowest financial proposal at \$6.8M, Nuctech was awarded the Standing Offer for x-ray machines.

This procurement process was conducted in accordance with the Treasury Board Secretariat (TBS) contracting policy as well as Public Works and Procurement Canada and Global Affairs Canada departmental contracting policies. At the issuance of the solicitation, Public Works and Procurement Canada indicated for the Tendering Procedures that all interested suppliers may submit a bid and accepted the submission from Nuctech since there was not a ban to have public procurement done with Chinese vendors.

The National Security Exemption (NSE) was not applicable in this procurement as x-ray machines are not covered by a NSE. A Security Requirement Check List (SRCL) was included in the solicitation as per standard procurement required documentation to be sent to Public Works and Procurement Canada. The SRCL was reviewed by the Public Works and Procurement Canada's Canadian Industrial Security Directorate (CISD) who determined that there were no security requirements for this procurement as x-ray machines do not store data, are not connected to the network and the machines are to be used in non-operational zones.

Although Nuctech is a first time vendor with Global Affairs Canada, it has had previous contracts with the Canadian Border Services Agency (CBSA). On the last contract awarded to Nuctech, Public Works and Procurement Canada's Canadian Industrial Security Directorate (CISD) asked that if this company were to win another contract, to clear it through them first.

### Analysis of procurement options going forward:

1. Option 1: Cancelling the Standing Offer and relaunching the bidding process for a new Standing Offer a. How:

- i. The cancellation, if agreed upon by PSPC, is done through PSPC since they are the contracting authority.
- ii. For the relaunch of the solicitation, AWC-CSS to works on updating the requirement that would include updated specifications, security requirements, and a revised evaluation grid.
- iii. Discussion to be held with PSPC on the procurement strategy to determine how to proceed with the solicitation and opening the bidding process in accordance with Canada's obligations under the trade agreements (if they are deemed applicable this time) while ensuring Canada's security interests are well addressed.
- b. Advantage(s):
  - i. No apparent advantage on the cancellation other perhaps public perception.
- c. Disadvantage(s):
  - i. Risk of litigation from the vendor who may not be satisfied with any reasons provided by Canada to cancel the Standing Offer. Not that the risk is high for the litigation to occur, or the vendor being successful in this exercise, but a litigation that may be long-lasting, and maintaining attention on this may not be in Canada's best interest.
- d. Other pertinent factors to consider:
  - i. This needs to be done with a concurrent strategy to procure for short term needs from the Missions while the new solicitation process is worked on that may take 6+ months depending on the updated

- works on the procurement documents (SOW, security, Evaluation Criteria), and procurement strategy to be used for the relaunch.
- ii. Procurement for short term needs may mean the issuance of multiple sole sources by PSPC (given the circumstances, they will probably be willing), and this will also probably mean higher prices for the equipment and services to be obtained.
- iii. The updated procurement strategy may not be simple to identify if Canada wishes to target specific pool of vendors with potential difficulties in establishing defendable criteria to set aside certain category of vendors. For example.
  - 1. A foreign company with an office in Canada submitting a proposal from Canada's office, is considered a Canadian company. How to approach this from the perspective of the ownership of a company rather than if it is considered as local? This subject not an easy one and it is not believed that many serious analyses are done on this topic. Will probably require consultations with GAC legal services, SPP, and partners from OGD such as PSPC and Industry Canada.
  - 2. How to ensure that, as we fenced our requirement and leave out certain less desirable vendors, opportunities are not created for other equally non-desirable vendors.
- iv. Since the Standing Offer established is a National Master Standing Offer and open to all Departments to use, if the intend is for Canada not to make use of it, there is a need seek for PSPC's assistance in notifying other Gov Departments and Agencies not to make use, even if they notice that the equipment and services offered match their needs.
- 2. Option 2: Not utilising the Standing Offer issued, and issuing another solicitation to establish an additional Standing Offer with a new vendor with increased security vetting.

Without cancelling the existing Standing Offer, GAC could immediately collaborate with PSPC to launch another solicitation to get a 2<sup>nd</sup> vendor that better fits its security requirements and interests.

This would reduce the risk of litigation.

Most analyses from option 1 remain valid for this option.

3. Option 3: There is always the possibility to make use of the Standing Offer with utmost caution to respond to current urgent needs, if security can be assured, while working with PSPC on establishing a 2<sup>nd</sup> Standing Offer (as explained in Option2). Given the circumstances, this is not likely an option that aligns with current expectations.

If a NSE could be invoked (with PSPC approval), future X-Ray requirements could be exempted from the Trade Agreements and allowing Canada to better target our requirements to vendors with interests aligned to ours. However, as indicated before, excluding certain foreign vendors may not mean excluding foreign owned vendors, and this question may need to be further discussed with pertinent SMEs.

- The intent of our lifecycle replacement initiative for detection equipment was to replace all x-ray machines currently out in the field over the next 3 year, at a rate of approximately 50 x-ray per year (for a total of 50 x-ray machines after 3 years.)
- I am currently finalizing with Paul a Roll-out Strategy Document to guide the cyclical replacement of the x-ray machines. The exact order of Missions to receive new x-ray machines is not yet known as I still need to assess the list of request I have on file, as well as request found in SIMS/CMT and consult with C Brach to establish the priority order.

### what exactly the equipment to be supplied is

- The intention of this procurement initiative was to provide x-ray machines and walk through metal detectors.
  - X-ray machines are know as Group 1 of the standing offer (awarded to NucTech)
  - o WTMD are known as Group 2 of the standing offer (awarded to Rapiscan)
- For Group 1, we required a conveyor style x-ray machines with monitor and operating systems, as well as warranty, maintenance, installation, training, yearly testing and disposal.
  - The warrant and maintenance components made the statement of work quite complex given the global reach of our needs.
  - o The technical requirements were quite detailed and complex, with the statement of work well over 40 pages.
- The standing offer is attached for your reference.

**Subject:** For USS: Status Update to NSIA on X-Ray Machines Standing Offer with Nuctech

Proposed text for USS update to NSIA/Vincent Rigby. Dominique

The requirement for x-ray machines and associated services are ongoing requirements for Global Affairs Canada's 178 Missions. Beginning in the summer of 2019, the International Platform Branch of Global Affairs Canada resumed work on the establishment of a long-term supply instrument that would allow the Department to respond to the needs of Missions to replace x-ray machines and provide associated services, such as installation, maintenance, yearly testing, training and disposal.

Public Services and Procurement Canada worked in collaboration with Global Affairs Canada and issued a request for standing offer on behalf of Global Affairs Canada on December 16, 2019. Seven bids were received on the x-ray machines portion of the request for standing offer. The bids evaluation process was conducted in two phases. In the first phase, the International Platform Branch as the technical authority, with the support of the Mission Readiness and Security Program representing Global Affairs Canada's Chief Security Officer, evaluated the technical proposal from the vendors. Through the technical evaluation, three vendors met all mandatory requirements, including Nuctech. The results of the technical evaluation were forwarded to Public Services and Procurement Canada for the financial evaluation and contractor selection based on the lowest financial proposal that was technically compliant. Since Nuctech met all the mandatory technical requirements and had the lowest financial proposal at \$6.8M, Nuctech was awarded the standing offer for x-ray machines.

This procurement process was conducted in accordance with the Treasury Board Secretariat contracting policy as well as Public Services and Procurement Canada and Global Affairs Canada departmental contracting policies, and applicable Trade Agreements.

The Global Affairs Canada standing offer awarded to Nuctech is not a contract and no call ups have been issued. In other words, no purchases of x-ray machines have been made under this standing offer. Furthermore, Nuctech is a first time vendor with Global Affairs Canada.

A National Security Exemption was not applicable in this procurement. A security requirement check list was included in the solicitation as per standard procurement required documentation to be sent to Public Services and Procurement Canada. There were no security requirements for this procurement as x-ray machines do not store data, are not connected to the network and the machines are to be used in non-operational zones.

GAC has retained Deloitte for a review of the procurement process for security equipment. The scope includes a review of our procurement planning for equipment used in our missions abroad to secure our people, information, and assets to assist us in the future in determining when it would be appropriate for us to set aside our obligation to comply with trade agreements to which Canada is a signatory by requesting a national security exemption for those future procurements.

A security review of our missions is not in the scope of this review as we already have an extremely robust capacity, framework, and governance structure under the Global Security Framework that does this. The equipment that is procured is identified by the outcome of a robust and cyclical review of the security needs of our missions abroad. This review is specifically for the security-related equipment that is being (and will be) procured, installed, and supported in our missions with a focus being on the equipment for which we do not already have a blanket national security exemption.

# MINA Briefing on Nuctech/China August 19, 2020 Annotated Agenda

### Standing offer financials and documents (ACM)

The standing offer awarded to Nuctech was for a period of 3 years ending on March 31, 2023. A provision exists that would allow the GoC to exercise 2 1-year options that would bring the SO to March 31, 2025.

The standing offer total estimated cost as per the 1<sup>st</sup> page of the SO signed by PSPC is \$0.00 as the SO is not a contract and does not bind the Government into spending any monies on it. Contracts are issued by placing call-ups (up to \$400K per call up by GAC) from the Standing Offer. GAC have not placed any call-ups yet, no equipment or services have therefore been procured from Nuctech and GAC have not issued any payments to this vendor. The value of \$6.8M is based on PSPC calculation of potential spending on this SO based on the financial proposal of Nuctech.

# Review of procurement of security equipment by Deloitte (ACM)

The ToR/scoping of the security equipment review is led by A branch, in consultation with S and C branches. Conversations they had with counterparts in the security community including PSPC and CBSA indicated that work related to evaluating security risks and position will require some time for additional consultation with and analysis from partners. A-Branch has contracted the services of Deloitte Canada, an independent consultant, to lead the joint A & C Branch review and draft a report that will outline the principles that will guide GAC's future procurement of security equipment. Whe are aiming at having recommendations within a month (end August 2020).

The Joint CFM-ACM frame for the review is:

- 1) A review of security controls as outlined in the Policy on Government Security. Lead: CSD, advised by AWD
- 2) A review of the procurement options to support the future acquisition of mission equipment, including a review of the appropriateness of using national security exceptions to permit GAC to restrict the number of bidders as would normally be required to comply with Canada's international trade agreement obligations. Lead is AAD, advised by CSD and AWD with consultations with SCM and PSPC

3) A review of options regarding the recently established Nuctech standing offer. Lead is AAD, advised by CSD and AWD with consultations with SCM and PSPC



### CITT complaint (ACM)

GAC was informed on August 6<sup>th</sup> that a CITT complaint had been filled by Calgary based KPrime technologies on the x-ray/walkthrough metal detector procurement process. The Tribunal made a decision on July 31, 2020, to conduct an inquiry into the complaint.

KPrime alleges that PWGSC failed to evaluate its bid in accordance with the terms of the solicitation, and that the winning bidder was ineligible to be awarded the contract.

PSPC is still receiving -

information. GAC will work in collaboration with PSPC who is the lead to respond to this CITT complaint.

Ground (s) for complaint per KPrime: "We were informed that we did not meet the mandatory requirements with our technology. Knowing how our instruments work, as well as our competitors, we know our instrument to be equivalent or better to what is in ... (other vendors names scratched out in the document shared with GAC)."

Remedies sought by KPrime:

- a. That a new solicitation for the designated contract be issued;
- b. That the bids be re-evaluated
- c. That the designated contract be terminated;

### Nuctech company overview (ACM)

From Wikipedia, Nuctech is a global company founded by a son of the former president of China, Hu Jintao, and is a state-owned business. The company's web site indicates they have sold equipment to over 130 countries and 5 continents. Turkey and Poland (maybe many more) seem to be NATO countries that have procured equipment from this vendor.

In Canada, based on the information found on PSPC's BuyandSell web site, 16 procurement were done with Nuctech since 2017, mainly for hazard detecting instruments and lab supplies. 15 came from CBSA with 1 SO awarded by PSPC for GAC X-RAY requirement.

# Canada / China Commercial relations (OGM)

**Current Bilateral Tensions:** 

The December 2018 arrest of Huawei Chief Financial Officer Ms. Meng Wanzhou led to a deterioration in Canada-China relations, which is negatively affecting the commercial environment. A May 2019 survey published by the Canada-China Business Council (CCBC) canvassed members on

impacts felt from the tensions. The survey reported that 18 percent of Canadian respondents (and 14 percent of Chinese respondents) experienced cancelled or postponed contracts or investment deals; 48 percent report they had or may cancel/postpone travel plans; 53 percent had made changes to their business plans; and roughly 20 percent were pessimistic about the future of their business with China.

Trade Policy Engagement (Possible Canada-China FTA):

From 2016 to 2017, Canada and China engaged in exploratory discussions for a possible Canada-China FTA. Four sets of meetings were held in 2017, but differences remain on issues including Government Procurement, State-Owned Enterprises (SOEs), Labour and Environment. Diplomatic tensions are limiting prospects to further FTA exploratory discussions or launch FTA negotiations.

### Physical security abroad (CFM)

GAC's Global Security Framework:

- Canada's approach to ensuring the safety and security of our staff and assets abroad is
  grounded in the Global Security Framework, which governs the interplay between threats
  and vulnerabilities across Canada's global mission network.
- Several functional experts within Global Affairs Canada play a role in ensuring the principles
  of the Global Security Framework are upheld, specifically when it comes to assessing threats
  and vulnerabilities, prescribing interim and long-term operational and physical security
  mitigations, and implementing those prescribed mitigations in the field.
- A risk-based analysis is used to determine the frequency and location of vulnerability and threat assessments, ensuring that inputs from both headquarters and the field are taken into consideration to allow for real-time responses.
- In addition to full vulnerability and threat assessments, security professionals also complete several focused security visits to assess and respond to any unexpected or rapid changes in the security environment that could have an impact on the overall security of our staff abroad. These scheduled and on-demand vulnerability assessments are complimented by quarterly threat and vulnerability reporting from missions (via Mission Security Officers and Readiness Program Managers), regular discussions between security practitioners at headquarters and field-based mission security teams, and close collaboration between the teams responsible for assessing and mitigating against both threats and vulnerabilities.
- Further, GAC is fully equipped to respond to unforeseen emergencies abroad via the Emergency Watch and Response Centre, which can rapidly assemble whole-of-department and whole-of-government responses to crises.

Responsive – percentage of missions with valid vulnerability assessments:

- As of fiscal year 2020-21, 83% of missions had valid vulnerability assessments.
- Many missions with less recent assessments were scheduled to be completed this year, which
  may not be possible given the ongoing impacts of COVID-19 on international travel.

X-Ray Machines:

- X-ray machines are an important tool for threat detection at missions and are in widespread use across Canada's network of mission as a part of the visitor screening process.
- As a tool they are much more effective than just metal detectors for detecting physical threat items as they are able to detect both metallic and non-metallic/organic threat items (ranging from knives to improvised explosive devices or their components)
- Many of these machines come with automatic threat detection capabilities that highlight
  areas of concern within the images, but <u>ultimately relies on people with appropriate training</u>
  to make the final decision
- As part of the goal of modernizing and enhancing security services, GAC has procured a computer based training program to complement the training and to monitor of the capacity of front-line security personnel in their screening functions at Missions.
- X-ray machines are not connected to SIGNET D.

### Trade Agreements (TFM/TCD)

### 1. Which trade agreements apply to Canada/China trade?

### **Bilateral Agreements**

- The Canada-China Promotion and Reciprocal Protection of Investment Agreement (Canada-China FIPA) entered into force on October 1, 2014.
- Canada and China held four sets of exploratory discussions toward a possible Canada-China Free Trade Agreement (FTA): February 20-24, 2018 (Beijing), April 24-28, 2018 (Ottawa), July 31-August 4, 2018 (Beijing), and September 22-23, 2018 (Ottawa). No discussions have taken place since and no decision has been taken on whether to launch FTA negotiations.
- There are a number of other types of bilateral recognition and cooperation agreements that also apply to Canada and China (notably, none on Government Procurement).

#### Multilateral Agreements

- Canada and China are both members of the World Trade Organization, and as such have multilateral commitments that apply to bilateral trade and investment. The WTO agreements that apply to trade between Canada and China include:
  - The General Agreement on Tariffs and Trade (GATT)
  - The General Agreement on Trade in Services (GATS)
  - o The Agreement on Agriculture
  - o The Agreement on Trade-Related Aspects of Intellectual Property Rights
  - The Agreement on the Application of Sanitary and Phytosanitary Measures
  - The Agreement on Technical Barriers to Trade
  - The Agreement on Customs Valuation

- The WTO Dispute settlement mechanism applies to these commitments and can be used by a Party in the event of non compliance.
- A host of other multilateral agreements, accords and conventions affect trade between Canada and China, including:
  - The Convention on the International Trade in Endangered Species of Wild Flora and Fauna (CITES)
  - The Metre Agreement (weights and measures)
  - o A number of International Labour Organization conventions
  - The Basel Accords on Banking Supervision
    - 2. Describe and explain very briefly the WTO, the Agreement on Government Procurement therein and the provisions under each in the context of our trade with China.
  - The World Trade Organization is an intergovernmental organization that is concerned with the regulation of international trade between nations (see above for key Agreements both China and Canada are apart of).
  - The revised WTO Agreement on Government Procurement (GPA) is a plurilateral agreement that establishes general principles and detailed procedural requirements that Parties are obliged to apply to covered procurement. These requirements help ensure that suppliers of goods and services from GPA Parties are treated in an open, transparent and non-discriminatory manner when they bid on government procurement contracts of other GPA Parties. Presently, there are 20 Parties to the GPA, including Canada, the EU's 28 Member States, Japan, Korea and the United States, which represent procurement markets of approximately US\$1.7 trillion annually.
  - China is not yet a Party to the revised WTO Agreement on Government Procurement (GPA) but tabled its application and initial market access offer to accede to the GPA in December 2007. Since then, China has submitted several revised market access offers – the most recent one was tabled on Oct. 26, 2019.
  - From an international trade perspective, Canada and China do not have government procurement obligations vis-à-vis each other.
  - Accordingly, Canada and China are not obliged to treat each other's goods, services and suppliers in a non-discriminatory, fair and transparent manner.

### 3. What is the role of Trade Agreements generally?

The general objective of all FTAs is to facilitate and establish the trade and
investment rules for the cross border movement of goods, services, people, ideas,
capital, and data.

- FTA's level the playing field vis-à-vis competitors in particular markets, and in some
  cases can provide a competitive advantage to FTA partners. They also provide
  producers with access to cheaper inputs and benefits consumers by lowering costs
  of goods and services.
- FTA's are governed by dispute settlement provisions allowing a Party to seek recourse in the event of non compliance.

### 4. Why generally are trade agreements good for Canada?

- Expanding trade and investment through negotiation of trade agreements is key to
  ensuring inclusive and sustainable prosperity for Canadian businesses and
  communities, where two-way goods and services trade accounts for approximately
  65% of Canada's GDP.
- Canada currently has 14 bilateral and regional FTAs in force, covering 51 countries and nearly two thirds of global GDP.
- Canada seeks to ensure that the benefits of trade and investment are widely shared, both in Canada and abroad. Canada also seeks to ensure that the economic, environmental and social implications of its trade agreements are thoroughly explored, and that benefits are maximized, while negative effects are mitigated.

### Procurement Process Background

The requirement for x-ray machines and associated services are ongoing requirements for Global Affairs Canada's 178 Missions. Beginning in the summer of 2019, the International Platform Branch of Global Affairs Canada resumed work on the establishment of a long-term supply instrument that would allow the Department to respond to the needs of Missions to replace x-ray machines and provide associated services, such as installation, maintenance, yearly testing, training and disposal.

It was determined that a standing offer was the most suitable supply instrument, which due to its non-binding nature, would give Global Affairs Canada the flexibility to issue contracts only when a need is identified through a call-up. Global Affairs Canada and the Government of Canada are not obliged to issue any call-ups during the lifetime of the standing offer and it has occurred before that standing offers have not been used. The Global Affairs Canada standing offer awarded to Nuctech is not a contract and no call ups have been issued. In other words, no purchases of x-ray machines have been made under this standing offer.

The International Platform Branch of Global Affairs Canada, as the technical and requisitioning authority, developed the statement of work and requirements definition, as well as the technical evaluation criteria and obtained the Departmental Contract Review Board approval for this requirement. Public Services and Procurement Canada was identified as the contracting authority as this requirement was above Global Affairs Canada's contracting delegation.

Public Services and Procurement Canada worked in collaboration with Global Affairs Canada and issued a request for standing offer on behalf of Global Affairs Canada on December 16, 2019, for an initial period of forty days in accordance with our obligations under the trade agreements. Following a number of extensions to address vendors' questions, the bid period closed in April 2020. Seven bids\* were received on the x-ray machines portion of the request for standing offer. The bids evaluation process was conducted in two phases. In the first phase, the International Platform Branch as the technical authority, with the support of the Mission Readiness and Security Program representing Global Affairs Canada's Chief Security Officer, evaluated the technical proposal from the vendors. In order to be further considered each vendor had to meet all mandatory requirements. Through the technical evaluation, three vendors met all mandatory requirements, including Nuctech. The results of the technical evaluation were forwarded to Public Services and Procurement Canada for the financial evaluation and contractor selection based on the lowest financial proposal that was technically compliant. Since Nuctech met all the mandatory technical requirements and had the lowest financial proposal at \$6.8M, Nuctech was awarded the standing offer for x-ray machines.

The standing offer was awarded to Nuctech on July 15, 2020. Public Services and Procurement Canada informed all non-winning bidders, including one Canadian firm, of the award of the standing offer to Nuctech. Public Services and Procurement Canada also notified unsuccessful bidders of available recourse mechanisms including the complaints processes at the Canadian International Trade Tribunal as well as the Office of the Procurement Ombudsman.

This procurement process was conducted in accordance with the Treasury Board Secretariat contracting policy as well as Public Services and Procurement Canada and Global Affairs Canada departmental contracting policies, and applicable Trade Agreements. Although Nuctech is a first time vendor with Global Affairs Canada, it has had previous contracts with the Canadian Border Services Agency. On the

last contract awarded to Nuctech, Public Services and Procurement Canada's Canadian Industrial Security Directorate asked that if this company were to win another contract, to clear it through them first.

Should Global Affairs Canada determine that security requirements are necessary in procuring x-ray machines, the Department could decide to not use the standing offer issued on July 15, 2020 and run a new procurement process that would include security requirements.

# National Security Exemption

The National Security Exemption (NSE\*\*) was not applicable in this procurement as x-ray machines are not covered. A security requirement check list was included in the solicitation as per standard procurement required documentation to be sent to Public Services and Procurement Canada. There were no security requirements for this procurement as x-ray machines do not store data, are not

connected to the network and the machines are to be used in non-operational zones. The NSEs provided for in all of Canada's trade agreements allow Canada to exclude a procurement from some or all of the obligations of the relevant trade agreement(s), where Canada considers it necessary to do so in order to protect its national security interests specified in the text of the NSE. The purpose of the NSE is to ensure that parties to the agreements are not required in any way to compromise their national security interests through application of the obligations of the trade agreements.

Invoking an NSE under the trade agreements does not affect the obligation to comply with the Government Contracts Regulations (GCRs), including such matters as sole source justifications, other sourcing strategy issues and contracting officer limits. Procurements for which an NSE is invoked and applied remain subject to other relevant regulations and governmental and departmental policies, which may include posting a Notice of Proposed Procurement (NPP) or an Advance Contract Award Notice (ACAN) on the Government Electronic Tendering Service (GETS) where appropriate, though the security requirements may, in some cases, preclude such actions.

# Global Affairs Canada Review of Security Equipment Procurement for Canada's Missions

## **Background**

Following the completion of a standing offer solicitation process for security equipment which produced a winning vendor which met the technical specifications of the tender but which creates vulnerabilities to hostile state espionage activities, the International Platform Branch (ACM) and the Consular, Security and Emergency Management Branch (CFM) of Global Affairs Canada (GAC) have identified a requirement to review the procurement process of its security equipment intended for missions.

This review is required to ensure current operations provide adequacy between:

- 1. Meeting demands for security equipment needed for the safety and security of employees, information and assets;
- 2. Respecting prevalent procurement and security policies, laws and regulations;
- 3. Obtaining value for the Crown, as well as
- 4. Ensuring GAC security equipment procurement are accomplished in consideration of Canada's existing and emerging interests.

## **Objectives**

GAC requires analyses and recommendations on security equipment procurement. These recommendations may relate, but not limited, to the following key elements:

- Role and Responsibilities of the various GAC branches and divisions involved;
- Roles and Responsibilities of Other Government Departments (OGDs) including Public Services and Procurement Canada (PSPC) and other applicable lead security agencies under the Policy on Government Security;
- Approval and review mechanisms;
- Governance;
- Alignment to the Government of Canada (GoC) and GAC policy on security;
- Procurement constraints including Trade Agreements applications;
- Alignment to Canada's existing and emerging interests.
- Alignment to emerging espionage threats to Canadian interests through its network of missions abroad.

In order to develop recommendations, The Consultant will review current operations at GAC in relation to the procurement of security equipment to understand and assess effectiveness, efficiency, and compliancy as well as how well this procurement meets current national interests' expectations.

### Scope

The scope will include interviews and data collection from sources identified by GAC, analysis of the data collected, and recommendations for improvement of current operations.

Analysis and recommendations will take into account best practices and leading developments in the public and private sectors.

ACM and CFM management and Subject Matter Experts (SMEs) will be consulted in the work, and will be providing data and perspectives, and validating and confirming working assumptions and findings along the way.

That was incorrect. \_\_\_\_\_\_ did not meet three of the mandatory technical requirements. The difference is unimportant as 100% of the mandatory criteria had to be met. For sake of accuracy, though, it was important to update that piece of information contained in the email from earlier today.

See below (not for sharing at this point please). Provided by AAD from conversations with PSPC:

Following a discussion with PSPC, the following was highlighted by the PSPC's desk officer.

- The \$5.4M figure alleged for is for the x-ray machines only. It does not include the install, training, warranty, maintenance, disposal.
- The \$6.8 of NucTech is all encompassing.
- PSPC did not give me the actual figure, but busted the \$6.8M when you included their install, training, warranty, etc.
- Looks like PSPC is currently working on a media line regarding this.

- The intent of our lifecycle replacement initiative for detection equipment was to replace all x-ray machines currently out in the field over the next 3 year, at a rate of approximately 50 x-ray per year (for a total of 50 x-ray machines after 3 years.)
- I am currently finalizing with Paul a Roll-out Strategy Document to guide the cyclical replacement of the x-ray machines. The exact order of Missions to receive new x-ray machines is not yet known as I still need to assess the list of request I have on file, as well as request found in SIMS/CMT and consult with C Brach to establish the priority order.

### what exactly the equipment to be supplied is

- The intention of this procurement initiative was to provide x-ray machines and walk through metal detectors.
  - X-ray machines are know as Group 1 of the standing offer (awarded to NucTech)
  - o WTMD are known as Group 2 of the standing offer (awarded to Rapiscan)
- For Group 1, we required a conveyor style x-ray machines with monitor and operating systems, as well as warranty, maintenance, installation, training, yearly testing and disposal.
  - The warrant and maintenance components made the statement of work quite complex given the global reach of our needs.
  - The technical requirements were quite detailed and complex, with the statement of work well over 40 pages.
- The standing offer is attached for your reference.
  - In developing statement of work, we referred to SoW prepared by CBSA and other departments, as well as consultations wit AAC. CSI also provided support in answering technical question's during the bidding process.

Overview of briefing

- Procurement process for x-ray machines initiated in spring of 2019 and standing offer awarded to Nuctech, a state owned Chinese company in July 2020.
- The Crown is not obliged to use this standing offer.
- Subsequent scrutiny has prompted us to contract with Deloitte to conduct a review of
  procurement process for security equipment including way-forward options for the
  Nuctech standing offer and for future procurements of x-ray and other security
  equipment.
- In parallel to this, GAC has conducted a new threat and risk assessment (late July) specifically related to this equipment and this contractor. This assessment will undoubtedly influence our way-forward approach.

### Security Assessments, Bruce Murdock

What we have learned

A new threat and risk assessment for x-ray machines was not done in 2019; reliance
was on approaches to previous x-ray procurements which concluded that there were
no security requirements given use of the machines and some mitigations.

### **Deloitte Review of Procurement of Security Equipment**, Dan Danagher *Go forward options*

- Deloitte is on track to reporting by early September 2020
- Deloitte has been interviewing GAC (A, C & I Branches) and PWGSC
- Deloitte is evaluating the possibility of: a blanket threat and risk assessment for all security equipment; classifying the technical specifications and procurement process; and creating a National Security Exemption for all security equipment for our mission network
- GAC is preparing the steps presuming that this is the option recommended and selected by GAC
  - Will not use the Nuctech standing offer, will ramp up a replacement procurement exercise with an enhanced security approach, and work with PSPC to address GAC's immediate equipment requirements.
  - Will begin review of requirements to protect technical specifications, vetting reliable bidders, etc.

The following was provided to me earlier this morning from AAD (Dominique Belanger):

Just for easier reference, the scope of the review being undertaken by Deloitte:

- 1) A review of security controls as outlined in the Policy on Government Security.
- 2) A review of the procurement options to support the future acquisition of Mission equipment, including a review of the appropriateness of using national security exceptions to permit GAC to restrict the number of bidders as would normally be required to comply with Canada's international trade agreement obligations.
- 3) A review of the go-forward options for the use of the recently-established Nuctech standing offer.

The review will cover the X-Ray SO, but the scope is larger than only X-Ray. We also expect recommendations on overall security controls, how to fence our requirements appropriately, and what are suitable options on the recently awarded SO for example.

We should caution that this is not only about the X-Ray or any specific security equipment.

will the review conducted by Deloitte include equipment such as x-ray machines?

From reviewing the two excerpts below (highlight mine), it is not entirely clear if x-ray machines will fall under the scope of the review or not. Can you please confirm?

There were no security requirements for this procurement as x-ray machines do not store data, are not connected to the network and the machines are deployed in public, non-operational zones. PSPC has the authority to approve such requests should GAC wish to do so in the future.

### The review

GAC has retained Deloitte for a review of the procurement process for security equipment. The scope includes a review of our procurement planning for equipment used in our missions abroad to secure our people, information, and assets to assist us in the future in determining when it would be appropriate for us to set aside our obligation to comply with trade agreements to which Canada is a signatory by requesting a national security exemption for those future procurements.

The scope includes a review of our procurement planning for equipment used in our missions abroad to secure our people, information, and assets to assist us in the future in determine when it would be appropriate for us to set aside our obligation to comply with trade agreements to which Canada is a signatory by requesting a national security exception for those future procurements.

I would caution against talking about the review with reference to countries to whom such procurements would be restricted as those restrictions would be determined for each and every equipment (and service) procurements we do in the future. While they may likely be restricted to 5eyes or other countries, that may also not be feasible and would require an industry capacity assessment or consultation which would go significantly beyond the mandate of this review.

A security review of our missions is not in the scope of this review as we already have an extremely robust capacity, framework, and governance structure that does this. The equipment that is procured is identified by the outcome of a robust and cyclical review of the security needs of our missions abroad. This review is specifically for the security-related equipment that is being (and will be) procured, installed, and supported in our missions with a focus being on the equipment for which we do not already have a blanket national security exemption.

### Proposed media lines:

- This is about a procurement for X-Ray machines and associated services for missions abroad which Global Affairs worked on for several months in collaboration with PSPC, the contracting authority.
- An open and competitive solicitation process was conducted in accordance with applicable procurement policies at GAC and TB, regulations, and our obligations under the trade agreements. A Request for Proposal resulted in 3 compliant bids received. Nuctech, being the top ranked vendor following the bids evaluation, was recommended for the award of the Standing Offer by PSPC. The standing offer was subsequently awarded to Nuctech by PSPC.
- A Standing Offer is not a contract and does not bind GAC or the Government of Canada into procuring any equipment or services from the vendor i.e the standing offer can be relatively easy to set- aside. No x-ray machines have been purchased yet from this vendor under this standing offer.
- Security was not a factor in this procurement as the Canadian Industrial Security Directorate (CISD) determined that there were no security requirements for this procurement. The reason there was no security requirement was that the X Ray machines do not store data, and the machines were to be used in non-operational zones.

### Proposed background for MINA:

GAC worked for several months on a procurement for X-Ray machines and associated services for missions abroad, in collaboration with PSPC, the contracting authority.

Through a request for proposal, the open and competitive solicitation process for the establishment of a Standing Offer was handled in accordance with applicable GAC and TB procurement policies and regulations, and our obligations under the trade agreements, and resulted in 3 compliant bids received. Nuctech, being the top ranked vendor following the bids

evaluation, was recommended for the award of the Standing Offer. The Standing Offer was subsequently awarded to Nuctech by PSPC.

The Standing Offer was awarded based on the vendor meeting all the technical requirements AND having the lowest price.

PSPC informed all non-winning bidders, including one Canadian firm, of the award of the Standing Offer to Nuctech. This seemed to be the trigger for a complaint from said vendor to the Canadian Council of Innovators (in addition to going to the media).

Although Nuctech is a first time vendor with GAC, it has had previous contracts with CBSA. On the last contract awarded to Nuctech, Canadian Industrial Security Directorate (CISD) asked that if this company were to win another contract, to clear it through them first. For the GAC procurement, our contact at CISD determined that there were no security requirements, and it was decided that the company was cleared. The reason there was no security requirement was that the machines do not store data, and the machines were to be used in non-operational zones.

PSPC is currently finalizing an official response to the media enquiry stating: "Nuctech Company Limited, from Beijing, was awarded one of the national master standing offers because their proposal met the mandatory technical requirements and offered the lowest price. This procurement did not include any security requirement."

Although not mentioned in the official response by PSPC to the media enquiry, through a discussion with the PSPC desk officer, there was a determination by PSPC Senior Management that there was no basis to stop the procurement with a Chinese vendor because Canada never stopped doing business with Chinese companies.

It is also important to note that this is a Standing Offer and not a contract. In a Standing Offer, a contract is only entered into when a call-up is placed. It is therefore possible (although counterproductive) for GAC to not to make use of the Standing Offer by not placing any call-ups. Up till now, no call-up has been placed and no x-ray machines have been purchased from this vendor.

### MP Garnett Genuis (CPC),

I am responding today to your question on the procurement of x-ray machines for ongoing security requirements at Canada's Missions abroad and the award of a standing offer to Nuctech Company Ltd.

Before I begin, it is important to note that the standing offer awarded to Nuctech is not a contract and does not oblige Canada to purchase from this supplier and in fact, no purchases have been made.

The security of staff and visitors at Canada's embassies and consulates around the world is a top priority and my goal is to reassure and demonstrate that the criteria which governed officials' actions and decisions throughout the procurement process were the security of Canada's Missions, a fair and transparent procurement process and value for Canadians.

In the summer of 2019 Global Affairs Canada started work on a long-term supply instrument for the replacement of x-ray machines and associated services such as installation, maintenance, yearly testing, training and disposal, for our Missions abroad.

It was determined that a standing offer was the most suitable supply instrument, which due to its non-binding nature, would give Global Affairs Canada the flexibility to issue contracts only when a need is identified through a call-up. Global Affairs Canada and the Government of Canada are not obliged to issue any call-ups during the lifetime of a standing offer.

Public Services and Procurement Canada worked with Global Affairs Canada and issued a request for standing offer on December 16, 2019. Seven bids were received. Nuctech met all the mandatory technical requirements, had the lowest financial proposal at \$6.8M and was awarded the standing offer for x-ray machines on July 15, 2020. This procurement process was conducted in accordance with the Treasury Board Secretariat contracting policy as well as Public Services and Procurement Canada and Global Affairs Canada departmental contracting policies.

I have been assured by Departmental officials that all rules, regulations, trade obligations, and security considerations were duly addressed and adhered to in all steps of the management of this procurement. While I always have great confidence in their work, I have directed my officials to conduct a review of this procurement and assure me that this procurement, its eventual successor, and others like it will continue to be conducted in a fair and effective manner and maintain the safety of our hard working local and Canadian staff at Canada's missions around the world.

In closing I can assert and have clearly demonstrated that, the ongoing security of Canada's Missions abroad, a fair and transparent procurement process and value for Canadian's are the criteria that governed Global Affairs Canada actions and decisions. Furthermore, I repeat that the standing offer awarded to Nuctech is not a contract and no purchases of x-ray machines have been made under this standing offer.

Awarded to Nuctech – met all technical requirements, lowest bid of \$6.8 million.

### Deloitte review of procurement process for security equipment

Will include way-forward options for procurement of security equipment and Nuctech standing offer specifically such as:

- 1) Do not use standing offer. Standing offers do occasionally go unused for a variety of reasons. Normally, few legal consequences associated with this option especially if we can point to a change in requirements subsequent to the award of the original standing offer. A revised security assessment is a change that would support such action. This would trigger a request to Public Services and Procurement Canada (PSPC) for a national security exemption to our international trade agreement obligations, specifically the World Trade Agreement's Agreement on Government Procurement provisions that Canada has signed onto as a member of the World Trade Organization. That exemption would permit PSPC to reprocure the requirement for machines to a restricted group of qualified firms that would meet our security requirements.
- 2) GAC mitigates any perceived or potential technical risks related to Nuctech's equipment provided through the standing offer. Modify the terms of the standing offer to, for example, require a security-focused tear down of a random sample of machines as well as more stringent supervision and background checks for installation and service personnel.
- 3) GAC continues with the standing offer as-is with no changes.



### Context

- Previous Interactions: Minister Champagne has directed a review of the procurement of security equipment. GAC has contracted Deloitte. Review to be completed by early September.
- **Political Climate:** December 2018 arrest of Huawei CFO Ms. Meng Wanzhou led to a deterioration in Canada-China relations, which is negatively affecting the commercial environment.
- · Key Issues:
  - Media articles (John Ivison of National Post) criticizing the procurement of x-ray machines from Nuctech, a Chinese state owned company.
  - Canada's approach to ensuring the safety and security of our staff and assets abroad is grounded in the Global Security Framework, which governs the interplay between threats and vulnerabilities across Canada's global mission network.
  - o GAC's **layered approach to security** involves physical security measures, operational security procedures and security intelligence information.
- Key Statistics: Nuctech is a first time vendor for GAC. CBSA, via a PSPC procurement, has
  contracts with Nuctech.

### Global Affairs Canada's Approach for the Procurement of Security Equipment

### Summary

The purpose of this memo is to provide information on Global Affairs Canada's approach going forward for the procurement of security equipment for Canada's mission network. This approach is informed by the recommendations in the Deloitte Review of Procurement for Security Equipment dated September 16, 2020, which identified opportunities for improvement with respect to future procurement of security equipment. The revised procurement approach that we are developing will recognize that technical specifications and other sensitive information will be carefully managed for all procurement for services and equipment where the primary role is to protect our people, information and assets at Canada's missions abroad.


### Background

- 1. A procurement process for X-ray machines used in Canada's missions abroad was initiated by Global Affairs Canada in spring of 2019. Public Services and Procurement Canada led the solicitation as the contracting authority and a standing offer was awarded to Nuctech in July 2020. Global Affairs Canada conducted a threat and risk assessment (late July 2020) specifically related to this equipment and this contractor. The threat and risk assessment concluded that X-ray machines and their maintenance at Canadian missions abroad could be leveraged for technical and insider spying against Global Affairs Canada. Procurement from Nuctech is assessed to constitute an elevated threat because of the company's direct relationship to, and legal obligations toward Chinese authorities. Installation and maintenance of these machines at Global Affairs Canada missions would need to address the Department's espionage threat profile and require corresponding safeguards including, hardware and software security inspections and strict vetting and/or surveillance of technical and maintenance staff. These measures could partially mitigate, but would not eliminate, the elevated threat from espionage. As a result of the information in this threat and risk assessment, the revised security posture it requires and recommendations from the Deloitte Review on the Procurement of Security Equipment, Global Affairs Canada has not and will not use the Nuctech standing offer.
- 2. In early August 2020, Global Affairs Canada contracted with Deloite, a third party organization with expertise in this area, to conduct a review of the procurement process for security equipment including options for the Nuctech standing offer and for future procurement of X-ray and other security equipment. The review concludes: "During our review we did not observe any instances of non-compliance, although as noted above, we have identified opportunities for improvement with respect to future procurement of security equipment. The specific procurement under review could benefit from a re-evaluation considering the above-noted recommendations. This could include a re-examination of the technical and security requirements in collaboration with security (subject matter experts) as well as revisiting whether the technical requirements should be posted on a public site (i.e. BuyandSell)."
- 3. Global Affairs Canada is developing a revised procurement approach that will include:
  - A) defining a 'security equipment' category which could include armoured vehicles, personal protective equipment, chancery electronic security systems, personal safety radio network, chancery site plan, CCTV, detection, minor security equipment, lock shop equipment, physical security infrastructure and global positioning systems;
  - B) A process for consulting with security experts and integrating information and intelligence from them to create the procurement;
  - C) Creating a National Security Exemption for security equipment that will enable Global Affairs Canada and other departments to limit solicitations to trusted suppliers;
  - D) Applying the recommendations from the July 2020 threat and risk assessment to create and vet a list of trusted suppliers; and
  - E) Managing the publication of information related to security equipment procurement. This procurement approach will also address the need for ad hoc purchases where security equipment has become obsolete or cannot be repaired.
- 4. The Department has already begun to work with Public Services and Procurement Canada and stakeholders on our go forward approach. An aggressive procurement timeline, which is dependent on establishing a National Security Exemption currently under development in consultation with Public Services and Procurement Canada, Public Safety Canada and the Communications Security Establishment of Canada, could result in a new standing offer for X-ray machines within a 12-month timeline. Ad hoc purchases, also aligned with our go forward approach, required in cases where X-ray machines have become obsolete, are irreparable or there is an imminent need could be completed within a few months.



# **Executive Summary**

### Background

Global Affairs Canada (GAC) has an ongoing requirement to purchase security equipment for its missions abroad. Recently, GAC undertook a procurement process for two types of security equipment which resulted in two standing offers; one for each type of security equipment. The award of one of the standing offers to a state-owned Chinese firm recently received public attention.

In August 2020, GAC senior management engaged Deloitte LLP (Deloitte), a professional services firm, to perform this review.

#### **Objective and Approach**

The objective of this review was to assess GAC's procurement process as it relates to security equipment, specifically, the procurement process that resulted in the state-owned Chinese firm being awarded a standing offer for security equipment (the specific procurement) and to make recommendations for future procurement of security equipment. The review considered the requirements of Treasury Board (TB) policies; specifically, the Contracting Policy, the Policy on Government Security and the Directive on Security Management.

The review consisted of interviews with key stakeholders, examination of documents and a walkthrough of the specific procurement process. Key findings were summarized and validated with management.

### Findings and Recommendations

The review identified opportunities for improvement for future procurements of security equipment in the areas of increased integration of security in the materiel management life cycle, broader consultation throughout the procurement process for security equipment and additional guidance with respect to publishing technical requirements.

To address the findings, the following recommendations were made:

- 1. It is recommended that GAC increase the integration of security considerations into the materiel management life cycle, including procurement and contracting activities. This could include involving security subject matter experts/(SME) during the development of the departmental procurement plan.
- 2. It is recommended that GAC consider additional consultations and collaboration during the assessment of security-related requirements in the procurement process for security equipment. This could include:
  - Formalize additional steps or stage gates in the procurement process to evaluate, review and approve security-related requirements. This should apply to all procurement of equipment and/or services related to the provision of physical security, operational technology and information technology within missions.
  - b) Development of a guideline that considers GAC's specific security threats and vulnerabilities that indicates when a National Security Exemption is applicable.
  - c) Enhanced definition of roles and responsibilities for the review (e.g. security SMEs), approval and oversight over the development of the security requirements, including the Security Requirements Check List (SRCL) as well as security-related inquiries throughout the procurement process for security equipment.
  - d) Additional consultation with the appropriate GAC representatives and other government organizations such as public safety organizations, Shared Services Canada (SSC), and Treasury Board Secretariat (TBS) where appropriate per the Government of Canada's Policy on Government Security (Section 5 - Roles of other Government Organizations).



3. It is recommended that GAC develop guidance related to the management of security equipment procurements and disclosure of information related to technical requirements.

# Background, Objective and Approach

### 1.1 Background


Global Affairs Canada (GAC) has an ongoing requirement to purchase security equipment for its missions abroad. Recently, GAC undertook a procurement process for two types of security equipment. As the procurement exceeded GAC's authority, GAC engaged with Public Services and Procurement Canada (PSPC) to manage the procurement process. It was agreed that a standing offer was the most suitable supply instrument as it is non-binding in nature and provided GAC the flexibility to issue contracts on an as needed basis through call-ups. In addition, it was determined that it would be more efficient to combine the procurement for the two types of security equipment. The procurement resulted in two standing offers; one for each type of security equipment.

In July 2020, an article appeared in the *National Post* regarding the fact that one of the standing offers was awarded to a state-owned Chinese firm to supply security equipment to GAC. The article expressed concern regarding the award of the standing offer and called for a re-examination of the bid.

In August 2020, GAC senior management engaged Deloitte, a professional services firm, to perform this review.

### 1.2 Objective

The objective of this review was to assess GAC's procurement process as it relates to security equipment, specifically, the procurement process that resulted in the state-owned Chinese firm being awarded a standing offer for security equipment (the specific procurement) and to make recommendations for future procurement of security equipment. The review considered the requirements of Treasury Board (TB) policies; specifically, the Contracting Policy, the Policy on Government Security and the Directive on Security Management.



### 1.3 Approach

The review was conducted in three phases:


Reporting

The planning phase consisted of kicking off the engagement with key personnel from GAC, interviewing the procurement officer and examining background documents. A work plan was prepared at the end of the planning phase that outlined the activities to be completed by phase and timing of those activities.

During the conduct phase, the following activities were undertaken by Deloitte:

- Multiple interviews with key personnel from various branches within GAC, including International Platform and Corporate Planning, and Finance and Information Technology, to gain an understanding of the procurement process and how the technical and security requirements were developed.
- Interviews with GAC senior managements
- Multiple interviews with PSPC Procurement Branch to understand how they exercised their role.
- Examination of procurement and solicitation documents, Treasury Board policy instruments, governance records of decision, and other relevant documentation.
- Walkthrough of the specific procurement process to understand how the technical and security requirements were defined.
- Assessment of the procurement process for security equipment. This included development of review criteria and documenting how the specific procurement met those criteria.

During the reporting phase, findings and observations were developed and validated with key personnel. Recommendations were developed and a report was prepared and presented to senior management.



# 2 Overview of Security Equipment Procurement Process

The typical procurement process for security equipment within the Government of Canada, and specifically GAC, can be divided into four general phases as depicted in the diagram below.

### 2.1 Definition of the Requirement

Within this phase, the technical and security requirements are defined by the business owner within GAC. The definition of the technical requirements involves consultation within subject matter experts within the department as well outside the department for some of the specialized elements of security equipment.

With respect to the security requirements, a Security Requirements Check List (SRCL) is prepared. It is the mechanism whereby the technical authority (TA) identifies security elements (e.g. physical security) related to the procurement. Factors such as whether the equipment will be in the secure zone of a mission, connectivity to the mission's network and whether the equipment stores data are considered when preparing the SRCL. Depending on the security requirements identified, a SRCL could be reviewed by the TA, the departmental Chief Security Officer (CSO) as well as the contracting authority. During this phase, the procurement officer also determines whether the specific type of security equipment is included within the pre-existing National Security Exemptions (NSEs) for the department.

Significant procurements are presented to GAC's governance committee (i.e. Departmental Contract Review Board). This committee is charged with reviewing the nature of the procurement, the appropriateness of the procurement tool, estimated value, and whether or not there are sufficient funds within the budget for the procurement.

Procurements that are within GAC's authority (i.e. \$2 million) are managed by procurement officers within the department. Where the value exceeds \$2 million, the procurement process is managed by Public Services and Procurement Canada (PSPC). In the latter case, GAC collaborates with PSPC to finalize the statement of work and to select the appropriate procurement instrument that meets the needs of the department. Along with requisition form (Form 9200) and the procurement documentation, GAC submits any security requirements to PSPC. Submission of the SCRL to PSPC is not mandatory if, on the requisition form, the department has checked the box "No security requirement".

In addition, the basis of evaluation is established during this phase. Lowest cost that meets the mandatory technical requirement is often used for goods or services that are readily available in the marketplace. For this basis of evaluation, if a bidder does not meet any of the mandatory requirements, they are automatically disqualified. The vendor that meets the mandatory technical requirement and has

the lowest price would be the successful bidder. For this type of procurement this is considered the best value for the Crown.

The management of the procurement by PSPC includes playing a challenge role. PSPC reviews the stated requirements and works with GAC to ensure that the language is inclusive and does not limit competition. PSPC also provides advice on the type of procurement vehicle that will be used PSPC may recommend combining procurements if the goods or services are similar.

### 2.2 Solicitation


Once prepared, the Request for Proposal (RFP) is posted publicly on the BuyandSell portal for the required 40 days. The solicitation period can be extended to accommodate bidder questions and responses from the Crown.

The RFP includes instructions for bid submission, basis of evaluation, the technical requirements, and resulting clauses of the contract. In addition, the RFP stipulates that technical bids be submitted separately from the financial bid and that all bid information be sent directly to PSPC.

Security requirements are also described in the RFP and, typically, the SRCL is posted along with the RFP. The security requirements could include industrial security requirements for the bidder as well as security clearance for personnel involved in delivering the contract. In addition, the security requirements could trigger a National Security Exemption which would limit the distribution of the RFP. In some cases, the potential bidder may be required to demonstrate appropriate security clearance before gaining access to the technical requirements.

#### 2.3 Bid Evaluation

As the Technical Authority, GAC is responsible for the evaluation of the technical bids received. PSPC provides the technical bids for evaluation to GAC but retains the financial bids. GAC establishes a team to assess the bids. After evaluating the bids individually, the team meets as a group to review the results of the evaluation and arrive at a consensus of which bids have met the technical requirements. Proposals that do not meet the mandatory technical requirements are considered non-compliant. The results of the evaluation are shared with PSPC. At this point, PSPC reviews the financial bids. Consistent with the established basis of evaluation, the winning bid is the one with the lowest cost amongst the compliant bids.



#### 2.4 Award

PSPC submits the successful bidder's name through the Integrity Regime where PSPC verifies whether the supplier or any of its affiliates have been determined to be ineligible or suspended, in accordance with the Ineligibility and Suspension Policy. If a supplier has been convicted of an offence listed in the Policy¹ within the past three years in Canada or abroad, the supplier will be determined to be ineligible to be awarded a federal contract for a period of ten years. If a supplier is charged with one of the listed offences, the supplier could be suspended. If there are any concerns or issues at this stage PSPC would advise GAC. If no issues arise from the Integrity Regime verification, the standing offer is

## 3 Findings and Recommendations

During the review we identified opportunities for improvement for future procurements of security equipment in the areas of increased integration of security in the material management life cycle, broader consultation throughout the procurement process for security equipment and additional guidance with respect to publishing technical requirements. Details of the findings and recommendations are provided below.

### 3.1 Increased integration of security considerations in the materiel management life cycle

It was noted that the department has a procurement planning process for significant procurements and that the plan is presented to the Departmental Contract Review Board. The security subject matter experts (SME), however, are not typically included in the procurement planning process. It was also noted that while procurement personnel are experienced in procuring security equipment and have a high-level understanding of the department's security requirements, security SMEs are best positioned to keep abreast of evolving security threats around the globe.

Involving security SMEs during the planning phase of the materiel management life cycle increases the likelihood that security requirements will be identified in a more timely manner.

It is recommended that GAC increase the integration of security considerations into the materiel
management life cycle, including procurement and contracting activities. In particular, this could
include involving security subject matter experts during the development of the departmental
procurement plan.

### 3.2 Broader consultation and collaboration throughout the procurement process for security equipment

It was noted that although a Security Requirements Check List (SCRL) is required to be prepared through consultation with other branches within the department early on in the procurement process for a piece of security equipment, given the typical duration of procurements of this nature (i.e. more than one year) and the nature of the equipment, it is likely that the procurement process for security equipment could benefit from further consultation throughout the procurement process. Broader and more frequent consultation may increase the likelihood that appropriate security requirements and resultant measures (e.g. National Security Exemption) are identified throughout the procurement process for security equipment.

- It is recommended that GAC consider additional consultations and collaboration during the assessment of security-related requirements in the procurement process for security equipment. This could include:
  - a) Formalize additional steps or stage gates in the procurement process to evaluate, review and approve security-related requirements. This should apply to all procurement of equipment and/or services related to the provision of physical security, operational technology, and information technology within missions.
  - b) Development of a guideline that considers GAC's specific security threats and vulnerabilities that indicates when a National Security Exemption is applicable.


- c) Enhanced definition of roles and responsibilities for the review (e.g. security SMEs), approval and oversight over the development of the security requirements, including the SRCL as well as security-related inquiries throughout the procurement process for security equipment.
- d) Additional consultation with the appropriate GAC representatives and other government organizations such as public safety organizations, Shared Services Canada (SSC), and Treasury Board Secretariat (TBS) where appropriate per the Government of Canada's Policy on Government Security (Section 5 Roles of other Government Organizations).

### 3.3 Additional guidance on when technical requirements should be made public

We noted during the review that if no specific security requirements are identified for the procurement of security equipment, the technical requirements are published on BuyandSell, which is accessible to the public. There are currently no specific guidelines that define when or if technical requirements for security equipment should, or should not, be disclosed.

Based on the potential sensitive nature of the technical requirements for security equipment, it is important for GAC to consider who has access to this type of information and whether it should be publicly available.

3. It is recommended that GAC develop guidance related to the management of security equipment procurements and disclosure of information related to technical requirements.



### 4 Conclusion

During our review of the procurement of security equipment that resulted in a standing offer being awarded to a state-owned Chinese firm, we did not observe any instances of non-compliance, although as noted in the previous section, we have identified opportunities for improvement with respect to future procurements of security equipment.

The specific procurement under review could benefit from a re-evaluation considering the recommendations noted in Section 3 of this report. This could include a re-examination of the technical and security requirements in collaboration with security SMEs as well as revisiting whether the technical requirements should be posted on a public site (i.e. BuyandSell).


